 - 1. MB- Still is wants to see the actual language, and it has not been circulated since last month.
 - 2. Deanna Hunt- SLC thought that this initiative just made sense.
 - 3. MB- A draft, has been circulated, but no official language is set yet.
 - 4. SW: The committee was comfortable moving for approval without having seen the official language considering the people and groups involved, namely JoAnn Hardesty, are knowledgeable and trustworthy.
 - 5. MB- Is uncomfortable endorsing an initiative without seeing any hard language but would be willing to follow the board's decision.
 - 6. JH- AM concerns from the previous week have still not been addressed.
 - 7. MBC- Echoes MB's concerns.

 - a. MB: What are the options? There are so many solutions and so many issues.
 - b. BK: Interested to talking with the Village Coalition about the potentials for the neighborhood. The Women's Village in Kenton is great example of solution. one Could they be speaker at the GMM?
 - 2. DB: Parking as a topic.

 - 3. DLW: Broadway/Weidler Traffic Corridor. Potential to lower Speed Limit?
 - a. DB: Broadway is one of the most dangerous roadways in the city.
