1. Welcome, identification of SGNA Board of Directors and introductions of neighbors and visitors. Board Chair, Brittain Brewer announced in the opening statements that five (5) seats were open on the Board for the evening's elections. Neighbors Lynne Coward and Dave Brook, as is their practice of challenging and attempting to discredit the Board at any and all General Meetings, if not all Board Meetings questioned why more seats were not open for elections. The Chair read from D. Brook's copy of the By-Laws - as follows:

ARTICLE VI --Elections & Voting, Section 3: **Board Members**: ... The chairman shall seek to insure that election of new Board members is staggered so that approximately 25% of the Board is being elected at any given time.

Five is a generous 25% of the 19 Board members allowed under Article IV of the By-Laws.

- 3. NECN Announcements/Notices no representative present.
- 4. Elections of members to the Board of Directors.
 - The following members (with vote tally) were nominated to stand for election:
 - Stephen Chase (42 of 54)
 - Brittain Brewer (30 of 54)
 - David Brook (31 of 54)
 - Michael Brown (38 of 54)
 - John Frewing (37 of 54)
 - Chris Tanner (40 of 54)

Those receiving the five highest numbers of votes were declared elected to the Board of Directors. A Ballot Tally is attached to these minutes. Ballots remain on file with the Board records and are available for review in response to a written request.

- 5. Finance Committee Report Treasurer & Secretary Treasurer's Report see attached document.
- 6. Events Committee (EC) the Committee Chair Stephen Chase gave a report on the Committee's activities this year and announcements on upcoming events. The Gulch Garage Sale resulting in \$88 profit for the NA. A welcome reversal of the approximate \$700 loss of the year before. The NA joined with neighboring organizations to sponsor a packed National Night in Holladay Park, another positive step in reclaiming our park from violent outsiders. The upcoming Gulch-O-Rama after Labor Day will have, again bring us all together to celebrate the diverse life of the Gulch.
- 7. Gulch Tree Team (GuTT) the Committee Chair., John Frewing gave a report on the neighborhood tree survey and upcoming events, but gave no information for inclusion in the minutes.
- 8. Land Use & Transportation Committee (LUTC) the Committee Chair, Carol Gossett gave a presentation and report on the events and activities of the last six months. The report is attached. The comments and questions of members were not recorded.
- 9. Safety & Livability Team (SALT) The Committee Chair, Dan Lerch-Walters did not give a report on committee activities but did have guests who gave a special presentation on graffiti. No guest names or information were submitted for inclusion in the minutes.






